

## Arizona Medical Forensic Exam Facilities

### VICTIM/SURVIVOR RIGHTS

**Under the Violence Against Women Act (VAWA), adult victims/survivors of sexual assault have the right to a medical forensic exam, at no cost to them, regardless of whether they report to law enforcement.**
